### PROCLAMATION

BY THE HONOURABLE THE ADMINISTRATOR OF THE  
PROVINCE OF TRANSVAAL.

Whereas it is provided in paragraph (d) of section *eleven* of the Game Ordinance, 1949 (Ordinance No. 23 of 1949), as amended, that the Administrator may, from time to time, after reference to the Fauna and Flora Advisory Board, by Proclamation in the *Gazette*, declare any defined area to be a game reserve;

And whereas it is provided in paragraph (a) of subsection (2) of section *two* of the Native Flora Protection Ordinance, 1940 (Ordinance No. 9 of 1940), as amended, that the Administrator may from time to time, by Proclamation in the *Provincial Gazette of the Province of Transvaal* establish one or more native flora reserves;

Now, therefore, under and by virtue of the aforesaid powers, and after reference to the said Board, I do hereby declare that the areas defined in the Schedule to this Proclamation shall henceforth be game reserves and native flora reserves, to which the provisions of the said Ordinances shall apply, and that the said reserves shall be known by the respective names set out in the said Schedule.

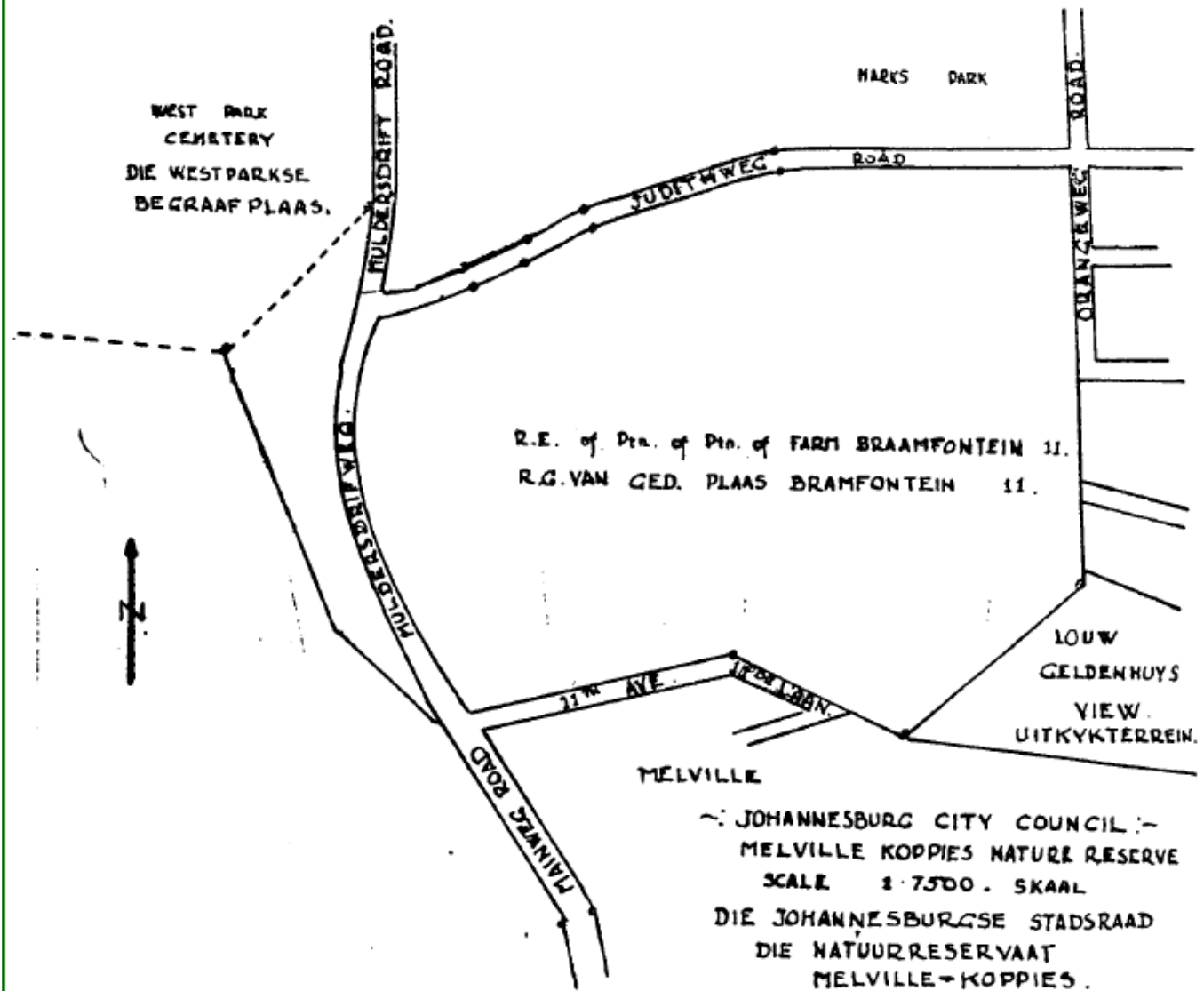

Commencing at the intersection of the south boundary of Judith Road and Orange Road with the western boundary of Emmarentia Township; and proceeding in a southerly direction along the western boundary of the said township for a distance of approximately 1,500 Cape feet to a beacon; thence in a south-westerly direction along the boundaries of Emmarentia and Melville Townships for a distance of approximately 780 Cape feet; and continuing in a north-westerly direction along the boundary of Melville Township for a distance of approximately 660 Cape feet and then in a south-westerly direction for 1,080 Cape feet along the northern boundary of Melville Township to the north-eastern beacon of the said township; thence in a north-westerly direction for a distance of approximately 470 Cape feet and across the stream to a beacon on the western corner of Portion G of portion of farm Braamfontein No. 11; thence in a north-north-westerly direction across Portion E of portion of the farm Braamfontein No. 11 for a distance of approximately 1,075 Cape feet to a point on the south boundary of the area known as West Park Cemetery; thence in a north-easterly direction along the side of the

Whereas it is provided in section 11 (d) of the Game Ordinance, 1949 (Ordinance No. 23 of 1949), that the Administrator may, from time to time, after reference to the Fauna and Flora Advisory Board, by proclamation in the *Gazette*, declare any area defined in such proclamation to be a game reserve until it is deproclaimed;

And whereas it is provided in section 2 (2) of the Native Flora Protection Ordinance, 1940 (Ordinance No. 9 of 1940), that the Administrator may from time to time by proclamation in the *Provincial Gazette of the Province of Transvaal*, establish one or more native flora reserves or cancel any such reserve, with effect from a stipulated date;

Now, therefore, under and by virtue of the aforesaid powers, after reference to the said Board, I do hereby declare that each of the areas defined in the Schedule hereto shall from the 13th December, 1966, be both a game reserve and a native flora reserve to which the provisions of the said Ordinances will apply;

And for general information it is hereby made known that I have assigned to each reserve the name indicated in the said Schedule hereto.

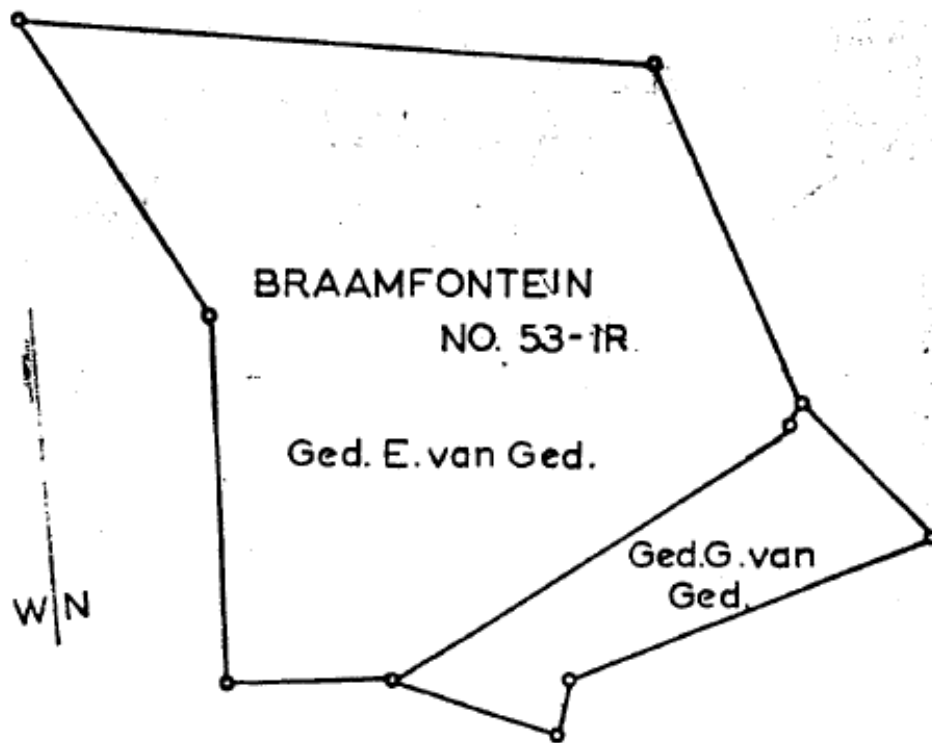
